Annual General Meeting Minutes

The President, John Harper called the meeting to order at 19:00 hrs at the Fredericton City Club, welcoming all members attending.

Old Business:

- 1. Minutes of Oct 2015 AGM were accepted.
- 2. Chief Range Officer's report; The Club Chief Range Officer, Peter Lach briefed the members on several points of information in regards to Range activities this past year. He reported that several FRSA members have been newly designated as Range Officers and have been issued the Club's RSO Orange hats identifying them as such. He also reported that the range has had another busy and successful year. The Club hosted several shoots and events that were very well attended, such as Sig Sauer Day and Korth Group Day as well as Cubs and Scouts shoots, CFB Gagetown Weapon Tech's Shoot, Practical pistol, Cowboy action / Wild Bunch and Bull's eye pistol and Rimfire all well enjoyed by members and guests. In addition Range improvements were identified, such as the extensive upgrades to the 600 m / 1000 m "Long Range", the replacement of soft steel to AR 500 steel targets and the addition of 23 rebar target stands. The new procedures for using the Long Range 600m from the "0 meter" firing position and the 1000m from the 0 meter, 100m and 200m positions for shooters who wish to shoot at 700M/800m or 900m were explained. (Note: Member's in attendance expressed that the significant re-construction improvements to the Long Range were impressive and excellent). In closing Peter asked and reminded members to be sure and review the revised and updated Range Safety Rules attached to their membership application forms.
